François Lafond



Previously, he was the executive director, member of the managing board of the French Aspen Institute and, director of the Paris office director of The German Marshall Fund of the United State. Before, François Lafond was a special adviser of the Italian Minister for Regional Affairs and Local Autonomies, responsible for international relations of the think tank Glocus in Roma, and associate professor at the Centre for European Studies of Sciences-Po Paris).

He was also special adviser of the Italian undersecretary of State for Foreign Affairs, deputy director of Policy Network in London, researcher and then deputy secretary general of the think tank Notre Europe in Paris, chaired by Jacques Delors, and research associate at the European University Institute's Robert Schuman Centre in Florence.

MAIN REPRESENTATIVES

Luca Bader

is the Chief Executive Officer of the Institute of European Democrats (IED). He is Chief of Staff of the Minister of Foreign Affairs of Italy. In the past ten years, he has served as responsible for Europe and North America at the Democratic Party (PD) in Italy and as advisor of the Committees of Foreign Affairs and Defence of the Italian Parliament. Also, he has advised several Italian ministries and private companies on EU and international affairs and has regularly written on Italian and EU affairs for several Italian publications. Luca has done research at the School of International and Public Affairs at the Columbia University in New York and at the Institute of International Affairs in Rome, where, as Senior Research Fellow, he researched, organised conferences and wrote on European Integration, Transatlantic Relations and International Economy. He has worked for the National Democratic Institute of Washington D.C., advising the program on building Institutions and Political Parties. In 2005, he was selected by the US Department of State for the "International Leaders Programme". From 2004 to 2006 he worked as advisor at the European Parliament in Brussels.



Miroslava Calegari

is the President of the youth organization Young Democrats for Europe (YDE). She is also a professional interpreter, public activist and volunteer. She is one of the founders of the Slovak European Democratic Party (EDP) which was established in 2009 – since then she has been leading its youth platform. For 4 years, she had been the president of Young Europeans (Mladí Európania, ME), the Slovak youth partner of EDP. Currently, she is the president of Young Democrats for Europe (YDE), youth organization of international political fraction of Parti démocrate européen-European Democratic Party (PDE-EDP), a member of ALDE Group of the European Parliament. Besides that, she cooperates in the

projects focused on legal recognition of young people in decision-making and she fights against discrimination, human rights violations and xenophobia.

Lýdia Hirošová

is the President of the Slovak youth organization Young Europeans (Mladí Európania, ME). She studies the political science at the University of Alexander Dubček in Trenčín, Slovakia and Prešov University in Prešov, Slovakia. She believes young people have to be active. Through her activities within Young Europeans, she tries to show that public affairs as well as the life in the European Union affect us directly. 1. PANEL: “The Youth in the EU – situation and facts”



Vlasta Kunová

is the Associate Professor and Vicerector of the Pan-European University in Bratislava, Slovakia academic and scientific Professor in the Faculty of Law of the Comenius University in Bratislava, Slovakia and Faculty of Law of University of Matej Bel in Banská Bystrica, Slovakia. She is a Jean Monnet Holder at the Comenius University and a holder of other 32 Slovak and foreign grants. Her specialisation is the Human Rights Protection in the EU and European Constitutional Law, External Relations of the EU and Economic and Monetary Union. Within the framework of the Jean Monnet Chair and Jean Monnet Module, she delivered lectures at many prominent Universities

in the EU, USA, and Asia. In past, she worked in the Slovak Government Office, Ministry of Culture and in the EU institutions in Brussels. She was an expert for the SlovakAid projects in Belarus and projects dealing with the state administration reform in the new EU member states. She published many textbooks and articles mainly on effectiveness of the EU decision making processes, human rights protection and harmonization of law. Her Jean Monnet Chair has been listed as one of the Top 20 Success Stories in the World.

Xabier Iñigo Ochandiano Martínez

is the Director of Planning and Innovation in Employment, at the Department of Employment and Social Policy of the Basque Government. He studied Business Studies with specialization in Business Management, Marketing Management and Business Administration at the University of the Basque Country (UPV/EHU). He has been Technical manager supporting SMEs and Commerce under the Special Plan of Bilbao La Vieja, San Francisco and Zabala and the Coordinator for Intervention Strategies in the Districts Lan Ekintza-Bilbao, SA and Head of the Promotion of Economic Activity.



Igor Hraško

is the Member of the National Council of the Slovak Republic, the sole constitutional and legislative body of the Slovak Republic. He is also an individual and independent member of the international Parti démocrate européen-European Democratic Party (PDE-EDP). In the National Council, he dedicates his parliamentary work to the sectors of education and culture and he specializes in the control of effective use of financial resources in both sectors. He tries to enhance the educational system in Slovakia and advance it to the EU level. He is a great supporter of the EU mobility programmes and Erasmus programme and he tries to support these platforms in the Parliament. He is also active folklorist and he tries to improve the conditions for people dedicated to folklore music and dance in Slovakia.

Peter McGuigan

is a researcher of the Institute of European Democrats (IED) and an assistant in the European Parliament to Irish MEP Marian Harkin (ALDE). His role consists of coordinating and advising on EU policy, specifically, on EU agricultural policy, EU public health and the Petitions Committee. He also worked as a Policy and Strategy Assistant for the Royal College of Physicians of Ireland. His role consisted in helping to develop the College's key policy areas, with the aim to influence healthcare policy in Ireland.



Marcela Hajtmánková

is the Director of the Department of Support and development of work with Youth of IUVENTA, Slovak Youth Institute. Within the department, she provides entire administration of grant programmes of the Ministry of Education, Science, Research and Sport of the Slovak Republic. She also organizes the subject olympiads and competitions for students. She also prepares the state policy materials and documents influencing life and status of the young people or entities working with youth (civil associations, youth centres etc.) and directly supports activities for children and youth work development through grant programmes administration. She supports activities in the area of work with talented young people by organizing of nation-wide round competitions, winner's meetings and committee meetings.

Sarah Robin

is the Deputy Secretary General and a member of the Bureau of youth organization Young Democrats of Europe (YDE), youth platform of international political fraction of European Democratic Party (PDE-EDP). Slavomír Rudenko

is a member of the Board of Institute of European Democrats, the Chancellor and Director for International Affairs at the Pan European University in Bratislava, Slovakia and a Lecturer in Public International Law and the Law of International Organizations at many universities in Bratislava, Slovakia. He did the Research project under the supervision of the Royal Norwegian Ministry of Foreign Affairs at the Institute for Public Law at the University of Oslo and he completed the special semester of foreign studies with the specialization on Public international law and European law at the University of Vienna. He was also a lawyer with Breyer Rechtsanwälte Law Firm in Stuttgart, Germany. He has worked within many international academic programmes, many of which have been dedicated to youth mobility, for more than 10 years. He published many articles and textbooks dedicated to Public International Law, External Relations of the EU, EU Constitutional Law and Comparative Constitutional Law. He is one of the most significant experts on the international law in Slovakia.

Štefan Grajcár

is the Head Consultant of the National Agency for Erasmus+ Programme for Education and Training Sectors, Slovak Academic Association for International Cooperation and Euroguidance Centre. He is one of the best experts on the EU mobility programmes and Erasmus programme in Slovakia. He was one of the founders and stood at the beginning of the creation of the National Agency for Erasmus+ Programme for Education and Training Sectors as well as its follower Euroguidance Centre. Through his work, he has had a chance to cooperate with many important European institutions, including the European Commission. He is also a founder of e-magazine “Career Consultancy in theory and practise”, which he considers as one of his most significant achievements.



Zuzana Poláčková

is the Head Coordinator of the programme Erasmus for Young Entrepreneurs in Slovakia.
