**Panel 2: Navigating the Digital Age: Complex Thought and Responsible Citizenship**

The internet gives us amazing freedom, but it also means we have big responsibilities. It's easy to get confused by fake news and to lose trust in what's real. Things are changing so fast, and it can be hard to know what to believe. This panel will help us learn how to think carefully, spot fake information, and make good choices online. We want to figure out how to be free online while still being responsible, create rules for how we use technology fairly, and teach everyone how to be good digital citizens. In short, we're asking: How can we use the internet to make our lives better, without getting lost in all the confusion?

- **Spotting Fake News**—How can we tell what's true online and what's not?
- **Freedom and Responsibility**—How can we say what we want online, but also be kind and respectful?
- **Rules for Technology**—How do we make sure technology is used fairly and ethically?

**Young Leaders Round Table: One Europe, One Defence: A Dream or Reality? (Chatham House Rule, Invitation Only)**

Recent shifts in global alliances and rising instability force us to ask if Europe can and should take charge of its own defence. Young leaders gathered by the Euro-Atlantic Center will dive into one of the most critical debates for Europe's future, exploring the question whether the idea of a single European defense force is a necessary step for navigating the geopolitical storm, or just a far-off dream? Essentially, we're asking: What is the future of European defence, and is unity the path to security and influence?

- **A United Force?**—Is a common European army realistic or even desirable compared to strengthening national forces? What are the pros and cons?
- **Standing Alone?**—Should Europe reduce its reliance on others (like the US/NATO) for its security? Is strategic autonomy the priority?
- **The Hurdles**—What are the biggest challenges—political, financial, logistical, and concerning national sovereignty—to creating a unified defence?

- **Global Impact**—How would a European army change relationships with the US, China, and Russia? Would it create more stability or tension?
- **Paying the Price**—How could the costs of enhanced European defence, unified or not, be shared fairly among member states?
- **Soft Power Europe**—What instruments other than military force or economic coercion (cultural, social, and intellectual) should Europe develop?
